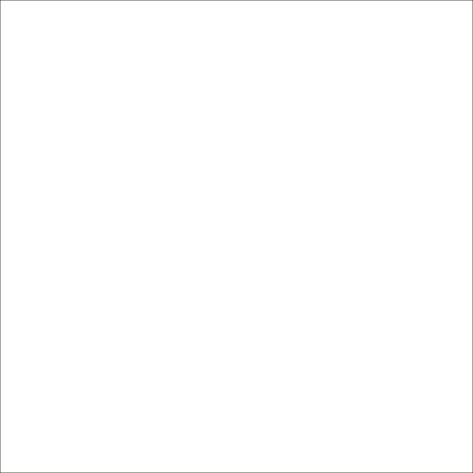

## 防静电

当静电超过一定限度时,会对设备产生一定的破坏作用。在与设备连接的通信网中,静电感应主要来自两方面:一是室外高压输电线、雷电等外界电场,二是室内环境、地板材料、整机结构等内部系统。因此,为防止静电的破坏,应保持:

设备及地板良好接地;

室内防尘;

温度、湿度条件适宜。

## 防干扰

设备使用中可能的干扰源(无论是来自设备,或应用系统的外部与内部)都是以电容耦合、电感耦合、电磁波辐射、公共阻抗(包括接地系统耦合)的传导方式对设备产生影响。因此,为有效抗干扰,应做到:

供电系统采取有效的防电网干扰措施:

设备工作地最好不要与电力设备的接地装置或防雷接地装置合用,并尽可能保持远距离;

远离强功率无线电发射台、雷达发射台等高频大电流设备;

必要时采取电磁屏蔽的方法。

#### 防雷击

在雷击强度超过一定范围时可能对设备造成损害,为了有效防雷,应做到:

保证机箱外壳用接地线接地良好;


保证交流电源插座的中性点接地良好;

为增强电源的防雷击效果,可在电源的输入前端加入电源避雷器。



## 四安装设备

## 1.安装前检查

• 检查包装箱物品

在安装设备之前,请先检查包装箱中的设备及组件,确保实际物品与装箱清单相符且物品无损坏现象。若发现问题,请及时与供应商或客服联系。



## 2.将NVR安装到机架上


安装前,请确保安装环境通风良好,并安装硬盘,硬盘安装方法见附录部分。 将NVR安装到机架上,必须要有托盘。

安装方法:

1)将两个挂耳分别用螺钉固定在设备的两侧,如下图所示.




2) 将设备水平放在托盘上,使两侧挂耳的螺孔与机架上的螺孔重合,然后用螺钉固定。



### 3.线缆连接

设备摆放好后,开始线缆连接。按照如下图所示,进行线缆连接。



## 4.上电、开机

连接完成后,给设备上电,开机。

开机后自动进入画面浏览并录像。点击任意选项,系统将弹出用户登录对话框,如图。

默认用户名:admin。 初始密码:admin123。



点击弹出软键盘

登陆设备后,可通过图形界面(GUI)对NVR进行配置。具体配置方法可参考随机光盘手册《NVR管理员指南》。

用户也可选择在PC机上通过NVRStation进行初始配置,配置方法可参考随机光盘手册《NVRStation操作手册》和客户端帮助文档。

#### About the NVR2881/NVR2881-I

#### 1 Product Introduction

The NVR2881/NVR2881-I is a turnkey solution for video surveillance and video recording. The NVR2881/NVR2881-I supports Open Network Video Interface Forum (ONVIF) and Real Time Streaming Protocol (RTSP) interoperability standards. Additionally, the NVR2881/NVR2881-I features native integration to cameras and encoders from third party manufacturers, therefore making it an open system.

The advanced system capabilities make the NVR2881/NVR2881-I easy to use with functions like Automatically Adding Devices and One-Click Partition and Formatting and meet various customer needs with functions like Record Synopsis and Privacy Mask for every day security users to advanced video surveillance users.

[Note] The NVR2881/NVR2881-I is referred to as the NVR in the following description.

The NVR works with the following management system and applications:

- NVR Station: is a complete system for device management, video surveillance, and video recording.
- NVR Station Web: is a web-based application of the NVR Station.
- Mobile NVR Client (MNC): is an iOS/Andriod-compatible mobile application of the NVR Station.

## 2 Product Appearance

## 2.1 Front Panel


On the front panel of the NVR, you can see the following items:

- One LAN indicator
- One ALM indicator
- One PWR indicator
- One power button
- One mute button (used to mute the beeper)
- Two 2.0 USB ports

The following table helps you read the preceding indicators.


Indicator	State	Description		
LAN	Green	The system is connected to the Internet.		
	Off	The system is disconnected from the Internet.		
ALM	Off	No system alarm is triggered.		
	Blinking red(0.25s on and 0.25s off)	A system alarm is triggered.		
PWR	Green	When the system is just started, the indicator will blink once. When the system starts operating, the indicator is steady green.		
	Off	The system is powered off or is rebooting.

## Installing the NVR2881/NVR2881-I

### 1 Preparations

#### 1.1 System Specifications

Ensure that the specifications of the NVR are complied with. For example, the operating temperature for the NVR must be within the range of -10  $^\circ$  C to 55  $^\circ$  C.

For the physical specifications of the NVR, see chapter 3 "Physical Specifications."

## 1.2 Equipment Cleanliness

The following table provides the mapping between the particle diameter range and number of particles per cubic meter.

Particle Diameter Range	Number of Particles per Cubic Meter	
[0, 0.5]	1.4×10 <sup>7</sup>	
[0.6, 1]	7×10 <sup>5</sup>	
[1.1, 3.0]	2.4×10 <sup>5</sup>	
[3.1, 5.0]	1.3×10 <sup>5</sup>	

You must install the NVR in an environment as free from dust and foreign conductive material (such as metal flakes from construction activities) as is possible.

#### 1.3 ESD

To reduce the effects of electrostatic discharge (ESD), you should observe the following quidelines.

- Wear a grounding wrist strap. If a grounding wrist strap is unavailable, touch an unpainted metal surface on the appliance chassis periodically to neutralize any static charge.
- Keep components in their antistatic packaging until they are installed.
- Avoid wearing clothing made of wool or synthetic materials.
- Ensure that the NVR is well grounded.
- Keep the area around the NVR clean, free of clutter, and well ventilated.
- Ensure that the operating temperature and the relative humidity within the range complying with the NVR.

#### 1.4 EMI

To shield electromagnetic interference (EMI), you should observe the following guidelines:

- Keep the ground system of the NVR away from that of the power supply system or lightning protection system.
- Place the NVR away from high-frequency devices, such as radio or radar stations.
- When necessary, deploy EMI shielding devices.

## 2 Unpacking

Perform the following steps to unpack the system:

- Inspect the package to make sure that it has not been damaged.
   If you find damage, contact the local authorized Kedacom agent.
- 2) Open the package and check whether any item on the packing list is missing.
- 3) Take all items out of the package and check whether any item is in poor condition. If you find damage, contact the local authorized Kedacom agent.

#### 3 Installing Disks

The NVR can be mounted on a 19-inch rack and it is around 3U high. Before mounting the NVR on a 19-inch rack, you must install disks.

If you do not install a disk:

• You cannot use the recording function.


When the NVR starts operating and detects that no disk is installed, the beeper will go off
and an alarm will be generated. To clear the alarm, on the OSD of the NVR, choose Main
Menu > Alarm > Active Alarm, and then select the alarm and click Clear.

### To install a disk:

 Slide the included key into the keyway of the lock on the front panel of the NVR and turn the key clockwise to unlock the slider.



2. Push the slider up to remove the protection mask from the NVR.




3. Press the button on the front panel of a hard disk tray until the cover on the front panel pops open.



Repeat this step for all the disks that you want to install.

4. Take out the hard disk tray, put a disk inside the tray, and fasten the disk to the tray using the included screws



Repeat this step for all the disks that you want to install.

5. Slide the tray into a disk slot along the rails of the disk slot. Note that you must keep the cover on the front panel of the tray open.



Repeat this step for all the disks that you want to install.

- 6. Press the cover on the front panel of the tray until you hear a click indicating that the tray is locked into the disk slot.
- 7. Push and hold the slider up to install the protection mask back to the NVR.
- 8 Release the slider
- 9. Slide the included key into the keyway of the lock on the front panel of the NVR2881 and turn the key counterclockwise to lock the slider.

#### 4 Installing the NVR

In a well ventilated area, install the NVR in a 19-inch rack as follows:


- 1. Insert the mother board and power module into respective slots on the rear panel.

  By default, the NVR comes with only one power module.
- 2. Choose a suitable location for the rack that is near a grounded power outlet.

Ensure that the rack is at least 0.6 m far away from the wall.

- Leave at least 1.5 m of space in the front of the NVR.
- $3. \ In stall \ the \ chass is \ provided \ by \ the \ rack \ manufacturer.$
- 4 Place the NVR on the chassis

5. Fasten the hangers on the left and right sides of the NVR to the rack with screws provided by the rack manufacturer through the four holes in the hangers.



- 6. Connect the green-yellow wire to the ground bolt of the NVR.
- 7. Connect the G-LAN 1 network port to the Internet.

Depending on onsite conditions, connect the GLAN2 and GLAN3 network ports to the Internet.

You are advised to use RJ-45 network cables.

- 8. Connect the NVR to a display that provides an HDMI and/or VGA port.
- 9. Connect the power cable to a power outlet.

[Note] You can connect the NVR to other devices (for example, a speaker). However, this document does not provide the corresponding details.

After the installation is completed, please note the following:

- By default, the NVR is switched on as soon as it is connected to a power outlet.
- To switch off the NVR, click the related button on the OSD of the NVR or on the NVR Station.
- The NVR Station is a complete system for device management and video viewing/recording/playback. The NVR Station is included in the KEDACOM Document and Utility CD. For details on how to use the NVR Station, see NVR Station User Guide.
- To switch on the NVR, press the power button on its front panel.

## 5 Power-on Self-Test

After the system is started up, check whether the the status of the LAN and PWR indicators on the front panel is normal.

- If yes, the system is operating properly.
- If not, contact the system administrator or the local authorized Kedacom agent.

#### **6 Product Care**

#### 6.1 Lightning Protection

To prevent the risk of lightning, you are advised to ensure the following:

- The NVR is well grounded.
- The green-yellow wire is properly connected to the ground bolt of the NVR.
- The connection between the natural points of alternating current (AC) outlets and the earth ground is normal.
- Based on onsite conditions, install lightning arrestors.

### 6.2 Lithium Battery Replacement

The system clock uses the CR2032 button cell lithium battery. When the battery loses its charge, the system may malfunciton. You must call the local unauthorized Kedacom agent to replace the battery. Do not attempt to replace the battery yourself.

Dispose of used batteries according to the manufacturer's instructions. If instructions are unavailable, contact your local waste disposal agency to learn about the nearest battery recycling place.

#### 6.3 Miscellaneous

Do not place heavy objects on the NVR.

Do not block the air vent.

Switch off the NVR if you want to let it idle for a long period of time.

Regularly check the status of hubs and switches to ensure that the NVR is properly connected to the transport network.

#### WHAT IS COVERED BY THIS WARRANTY?

Software distributed by Kedacom with or without the Kedacom brand (including, but not limited to system software) is not covered by this warranty. Please refer to the licensing agreement accompanying the software for details of your rights with respect to its use. Kedacom does not warrant that the operation of the Kedacom Product will be uninterrupted or error-free. Kedacom is not responsible for damage arising from failures to follow instructions relating to the Kedacom Product's use.

If during the Warranty Period, you submit a valid claim to Kedacom or an authorized Kedacom agent, Kedacom will, at its option, (i) repair the Kedacom Product using new or previously used parts that are equivalent to new in performance and reliability, or (ii) exchange the Kedacom Product for a refund of your purchase price.

A Kedacom replacement part or product, including a user-installable Kedacom part that has been installed in accordance with instructions provided by Kedacom, assumes the remaining warranty of the Kedacom Product or ninety (90) days from the date of replacement or repair, whichever provides longer coverage for you. When a product or part is replaced or a refund provided, any replacement item becomes your property and the replaced or refunded item becomes Kedacom's property.

Kedacom reserves the right to refund the purchase price as its exclusive warranty remedy.

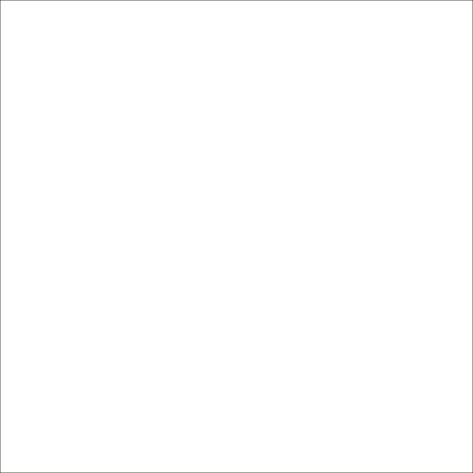
